Delegates Corner

First, I want to thank everyone for supporting our AKC Club Wall of Fame Plaque campaign. Our goal was \$2500 and we are just about there. The Yard Sale was a big success. I have been discussing with some members the possibility of visiting the AKC Museum of the Dog in the fall as a club trip. I will be sending an email to see if we have a sufficient number interest.

The March Delegates meeting is always considered as the annual AKC meeting with the Board Elections. This year two new candidates were elected to the AKC Board, Daniel Smyth, ESQ of Burlington Kennel Club and Steven Hamblin of the Pekinese Club of America. Dr. Charles Garvin from the Dalmatian Club of America was reelected.

In the Companion Events Committee Meeting

- Rally entries increased by 18.5% between 2017 and 2018. Obedience entries were down by 3%.
- An announcement about the Tulsa events was made. It was mentioned that AKC.TV will have coverage. This is the 25th anniversary of the National Obedience Championship and there will be celebration.
- The tracking “Making Life Easier” recommendations were approved by the AKC Board in February.
- Three changes to the Obedience regulations were approved in February by the AKC Board. They are in summary: 1) Modification of the Open B Point Schedule; 2) Any dog that earns a qualifying score of 197 or better in Open B and Utility B classes will earn one OTCH point when they do not earn points from the top four placements based on the Point Schedule; 3) OTCH title recognition by the number of times a dog has achieved the OTCH title requirement will be done by adding a numeric designation.
- AKC Rally RACH Title: In February 2019, all dog's records were recalculated using the new title requirements and title certificates were issued. Under the new title requirements, 41 dogs have earned the RACH title; 4 have earned the RACH2 title.
- There is a proposal for a collaborative effort to develop the idea of Obedience Freestyle. The objective is to develop a series of classes called Freestyle Obedience that utilizes obedience/rally skills and tricks. These classes are intended to be fun for exhibitors and entertaining for spectators. The Basic Structure: 1) Apply skills learned in obedience and rally. A dog must earn a CD title before entering the Novice Freestyle

class. 2) Routines must have a theme. 3) Costumes, props and music are encouraged. The freestyle classes must not be disruptive to neighboring activities. How to Proceed: The regulations for Freestyle Obedience will be developed through a joint effort between the CE staff and a subcommittee of the CE Delegates Committee. Input from clubs and participants in obedience and rally will be sought through surveys.

- After reviewing those responses on Agility changes, the staff has identified the following ideas to move forward and place on the April Board book. Under equipment: 1) Allowing alternating solid color weave poles. Also, those clubs using poles with stripes as currently allowed would no longer be able to use tape to define the stripes. They would have to be painted on or extruded in the PVC pole. Lower A-Frame to 5' for 12" dogs. Other changes moving forward 1) Allow dogs to have dye in their coats; 2) Allow Head Halters on the grounds and for dogs to be taken into and out of the ring; 3) Allow dogs to be entered in different jump heights that they are eligible for at a trial; 4) Allow dogs to be entered in Preferred and Regular classes on the same day. The staff is continuing to review changes to the height measurement system. Many dogs were measured with the proposed ulna system at the Agility Invitational in Orlando to collect data for review. Other changes require either more data or will require additional review of final wording for the changes. More items will be presented in the July Board book. One of those items to be presented will be the addition of “For Exhibition Only” to be allowed in the Time-2-Beat and FAST classes.
- Over 1900 free car magnets have been issued for the AKC FIT Dog Program. This program encourages dog owners to achieve a specific fitness goal. To become an AKC FIT DOG CLUB, a club must hold at least four group fitness walks per year or hold regularly-scheduled canine fitness classes. From a club's point of view, this “meet up” activity provides an opportunity to engage with new dog owners and perhaps obtain new club members. At this level of meeting, a club may apply for a free AKC FIT DOG CLUB banner which includes the name of the organization.

I have received one nomination for the CDTC AKC Outstanding Sportsmanship Award. The summary of the nomination is in this newsletter.

We'll discuss dogs' scent detection abilities, explain what the dogs are searching for, how we set up hides, and what factors affect searches. We'll provide "nose-on" opportunities for those new to the sport as well as for those with prior SW experience. Each participant will receive a copy of the current AKC Scent Work Regulations!

Sandi has 2 years of experience in Scent Work. Her Basenji, Figaro, has earned all 4 of the AKC Odor Search Division Novice titles (SWN) and 2 Advanced titles. Figaro has numerous SW placements and 1 SW HIT, as well as titles in other dog sports. Sandi has 36 years of dog training experience; her personal breeds are Basenjis and Cavalier King Charles Spaniels. She is a long-time member of CDTC and instructor.

Joan has been a member of Obedience Training Class of Harrisburg (OTCH), Pa., since 2001. Her dogs have earned the UUD and UCDX, CD, RN, WCRL MX, AKC Novice and Farm Dog titles. In addition to AKC SW, Joan is a C-WAGS scent judge. Joan has taught high school English for 35 years.

Rhonda has been a member of OTCH since 2012. After assisting with scent classes under Joan and John, she now teaches Beginner, Intermediate, and Advanced Scent classes. She has been a scent judge for C-WAGS for 3 years and is also an approved AKC Scent Work Judge. Rhonda has titled her Sheltie in C-WAGS, UKC rally, AKC Farm Dog and Tricks, Barn Hunt, and CDSP obedience. For 6 years, she has assisted with puppy kindergarten.

Training Corner

A Modest Proposal— Video Your Way to A Better Performance!

One of the most valuable things you can do to improve your obedience performances is to make a video recording to review after the trial. I did not begin to routinely record my entries until after my first UD, and I wish I had begun to do so sooner. After having a friend record Maggie and me competing, I was surprised by how little I was aware of several problems. It was also extremely helpful to be able to share the video with my mentors who then helped me to address the issues revealed by the videos.

I would like to make the following offer—if you record your performance at a trial and upload it to YouTube, I will be happy to take a look at it and then discuss it with you. I can offer advice and other feedback. Depending on the issues, I may be able to meet you at the clubhouse and help you out in person. If I can't help with a particular issue, I will try to refer you to someone who can. This offer extends to competitors at ALL obedience levels!

Situational Awareness— Where and Why Are Dogs Repeatedly Having Problems in the Ring?

Fenway and I had an interesting problem to solve at an obedience trial because of a very tough spot in the ring. There was a large dark stain in one corner of the ring that was right in the heeling path. I watched each of the four teams before us and saw that this spot was attractive to each of the dogs. I saw each of the dogs lose focus on the heeling section and become interested in the spot—sniffing and examining it at length. One “forgot” why he was in the ring and wandered around aimlessly. It was a shame to watch the end of focus and teamwork.

This presented a great situation for problem solving and strategy: How can I get Fenway past it and keep him from noticing the big stain on the mat floor?

We do a lot of agility and the courses always present off-course “traps”. The key to avoiding them is strategy and strong cues. A handler has to prepare in advance to take on those challenges by keeping the dog focused on *their* cues. We prepare strategic plans to avoid those off-courses.

Today’s “stain challenge” seemed to call for similar problem solving. I knew that my change of pace (speeding up just a bit) might be points off, but sacrificing a point or two for a Q seemed like the best choice.

Here’s what I did: I got Fenway past the problem area by quickening my pace just a bit while meeting his gaze and smiling in my most delighted way. I did this just a few feet before reaching the stain and before he could notice it. Whew—it worked!

I shared this with friends at the trial who were going to be in the same ring later on in Open and Novice. I told them how important it is to watch dogs in the ring to see if there are continual problems in the same area and figure out a strategy. What was really wonderful is that each of them Q’ed because they knew the big stain was there and they knew what to expect, while other dogs had continued problems and failures.

I think out of any trial I’ve ever been to—including agility and rally—this was the most interesting because it made me analyze a tough challenge and figure out my best way to solve it!

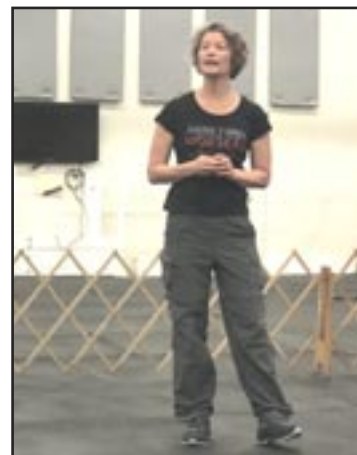
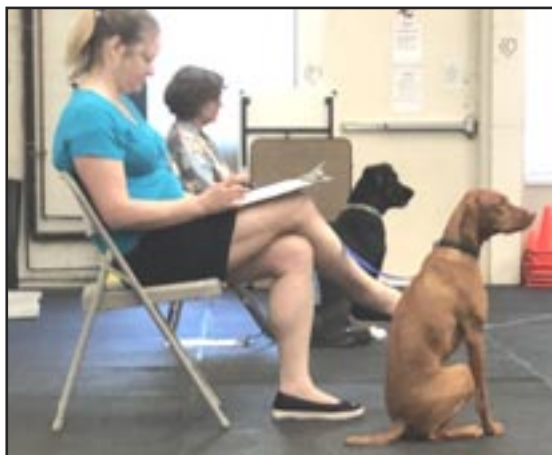
